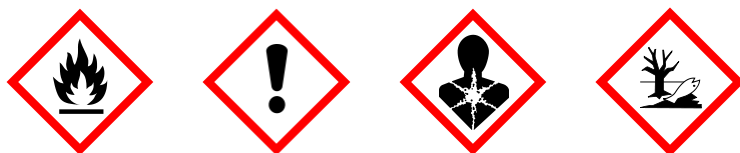

4. FIRST AID MEASURES

Eye contact
